2. Service Fees:

- 2.1 The college agrees to pay **Annual Maintenance Fee to the service provider**: This fee covers regular updates, bug fixes, security enhancements, and technical support for the college website for one year.
- 2.2 The service fees shall be paid annually.
- 2.3 Structure:
 - a) Domain Renewal: 800 Rs
 - b) 1 GB Workspace: 4000 Rs
 - c) Website Updation: 2500 Rs
- 2.4 The rate of the service will be changed as per market with mutual understanding between both parties.

3. Terms and Conditions:

- 3.1 This Agreement shall commence on the 11th June 2018 and shall continue for a period of **Five years**.
- 3.2 Either party may terminate this Agreement by providing 30 days prior written notice to the other party.

4. Intellectual Property Rights:

- 4.1 The college acknowledges that all Intellectual Property Rights (IPR), including copyrights, in the website and its content shall remain conferred with the college.



4.2 The Service Provider shall not claim any ownership rights over the college website or its content.

5. Confidentiality:

5.1 Both parties agree to keep confidential any information obtained from the other party during the term of this Agreement.

5.2 This confidentiality obligation shall survive the termination of this Agreement.

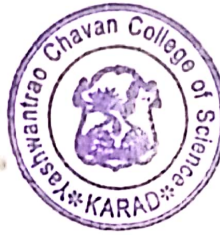

Annual Maintenance Contract Agreement

This Instrument Annual Maintenance Contract Agreement is made and entered into on 14th June 2018, by and between Yashwantrao Chavan College of Science Karad, Vidyanagar Karad and Maintenance Company Shivam Services Tadavale, Sangli.

1. **Scope of Services:** The Maintenance Company agrees to provide annual maintenance services for the instruments at Yashwantrao Chavan College of Science Karad, including but not limited to:
 - Calibration
 - Cleaning
 - Inspection
 - Repair
 - Replacement of parts if necessary
2. **Duration:** This Agreement shall commence on **14/06/2018** and will continue unless terminated earlier by either party in accordance with the terms herein.
3. **Service Schedule:** The Maintenance Company shall perform maintenance services on the instruments according to the following schedule:
 - Frequency: Quarterly / Annually.
 - Notification: The Maintenance Company shall provide the college 8 days prior notice before each maintenance visit.
4. **Payment:** In consideration for the services provided under this agreement, the college shall pay the Maintenance Company a total annual fee of Rs 4000.
5. **Responsibilities of the Maintenance Company:** The Maintenance Company agrees to:
 - Provide qualified technicians to perform maintenance services.
 - Use appropriate tools and equipment for maintenance activities.
 - Keep records of all maintenance performed on the instruments.
 - Notify the College about any significant issues discovered during visits.
 - Maintenance Company has responsibility for proper disposal of e-waste generated during repairing.
6. **Responsibilities of the College:** The College agrees to:
 - Provide access to the instruments during scheduled maintenance visits.



- Ensure that instruments are available and accessible to the Maintenance Company as per the agreed-upon schedule.
 - Promptly notify to the Maintenance Company regarding any changes in instrument conditions or requirements.
7. Either party may terminate this Agreement with 30 days prior written notice to the other party.


