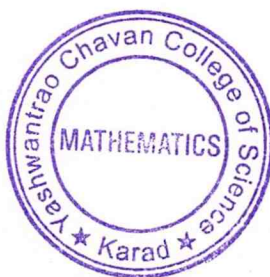

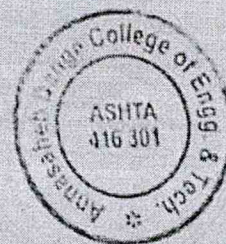

**Key Performance Indicators**

Faculty members should have to perform a variety of tasks pertaining to diverse roles. In addition to teaching-learning process, faculty members need to innovate and conduct research, keep abreast with changes in technology, and develop expertise for effective implementation of curricula. It is also expected to provide services to industry and society for solving real life problems. The performance of the faculty shall be strictly evaluated annually based on the following criteria:

**1. Teaching and Learning:**

Faculty should implement outcome based education system with assessment and attainment of COs, POs, PEOs and their mapping as per NBA/NAAC/ISO norms. The result of your course should be more than 80% leading to success rate of 100% as per NBA Norms.

**2. Quality Publications in Peer Reviewed Web of Science /SCI/Scopus Indexed Journals:**

Faculty should publish minimum 1 research paper in Peer Reviewed Web of Science / SCI / Scopus Indexed Journals per year.

**3. Faculty Development Programme:**

Faculty should attend minimum one FDP/STTP per year of minimum Two Weeks duration in the IITs/NITs/Institutions of national repute.

**4. Patents/IPR:**

Faculty should file minimum one patent / IPR for 3 years of service.

**5. Funded Research:**

Faculty should submit minimum one proposal to the various funding agencies to carry out major/minor research projects.


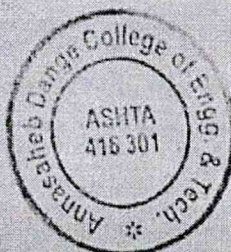
**6. Consultancy:**

Faculty should fetch consultancy of minimum Rs. 25000/- per year.

**7. Industry Institute Interaction:**

Faculty should get associated with minimum one small scale, one medium scale and one multinational industry of their specialization wherein the students allotted to them can be sent for internships/industry sponsored projects and placements.
